RFP Tools and Resources

Government Exec announced that federal employees will have an easier time following up on discrimination complaints against their agencies with the creation of a new online portal. While non-federal workers could long file claims with the Equal Employment Opportunity Commission online, EEOC just launched the portal for feds. The new tool will enable federal employees to make adjustments to their cases, add information and request hearings. In addition to filing requests for hearings and appeals, employees can update their contact information, add attorney data, check the status of their cases and respond to an agency's request to engage in alternative dispute resolution. Employees enrolled in the portal will receive email notifications whenever new information has been added to their cases. Federal employees still cannot file an initial charge against an agency through the online portal. That must occur through the agency's internal equal employment opportunity program. Initial submissions of evidence of discrimination and requests for EEO counseling must still go through that process as well. Employees can continue to request hearings, file appeals and otherwise manage their cases through writing and mailing paper documents, though EEOC cautioned that approach would delay the process.
